Session 1: Economic Valuation of coral reef ecosystems

a. Do you have examples of economic valuation of coral reefs being applied in practice? (e.g., in consideration of coastal land use, coastal/marine spatial planning, for determining compensation, etc.);

Our original estimate of \$200 BDS per meter square of coral has been used in determining monies to paid in two anchor damage cases to date. This estimate is extremely low and was calculated using only Fisheries and Tourism. A study is ongoing to provide a more realistic economic valuation of coral reefs in Barbados.

b. Do you have established methods for assessing these values? If so, please provide further information.

No, methods are being established as part of the aforementioned study.

Session 2: Designing the ICRI Regional Workshop on Sustainable Tourism

a. With respect to coral reefs, what does sustainable tourism mean to you?

Sustainable Tourism means a tourist product who's output does not have an overall negative impact on coral reefs, i.e. not resulting in net deterioration of reef via nutrient enrichment, physical damage etc.

- b. What are the key challenges you face to achieving sustainable tourism?
 - The belief of many tourism policy makers and that tourism is essential to SIDS at any cost, even at the expense of the natural environment.
 - The lack of an accurate economic valuation of coral reefs.
 - The lack of support of an educated public.

B. Summary of IYOR 2008 Activities

Our activities have a focus on public education which we believe is one of the primary issues in Barbados. Public education will take the form of the traditional community talks, with personnel travelling to the different communities. A book on the coral reefs of Barbados is being developed as well as a 7 part television series on the corals of Barbados. A meeting of Eastern Caribbean scientists and a training programme on Crime Scene Investigations fro Coral reefs is being planned as well as Mini Symposium for participants from primary Schools to University.
